- Assist wireline supervisor during operations.
- Make up tool string with minimum supervision.
- Maintain and clean all wireline equipment.
- Repair wireline equipment with little supervision.
- Drive company vehicle to location when required.
- Maintain neat housekeeping.
- Available on a 24 hour basis to respond to customer needs.
- Work assignments carried out to the highest quality level.
- Must understand and comply with all safety rules and company policies of Casedhole Solutions, Inc..
- Perform various other duties assigned by supervisor within the physical constraints of the job.

REQUIRED SKILLS:

- 0-3 years oilfield experience.
- Must have CDL with Hazmat endorsement.
- Must have completed the required training level for Intervention Services.
- Good communication skills.

TRAINING REQUIREMENTS: Must be able to complete or demonstrate competency in:

- **HOIST EQUIPMENT**
 1. What makes it work?
 2. Use of manual and air drum brakes.
 3. Limitation on draw works.
 4. All maintenance requirements.
 5. Measuring Head Maintenance

- **PRESSURE CONTROL**
 1. Be aware of all dangers that exists when working under pressure.
 2. Pressure ratings for related items and their specific use such as pack off, control head, hoses and valves, and lubricator.
 3. Understand and perform all steps necessary to equalize lubricator when running tools under pressure.

- **EQUIPMENT – SHOP & FIELD**

- **JOB OPERATIONS**

- **BASIC LOGGING AND PERFORATING DUTIES**
 1. Spot hoist unit in a safe and good operational manner
 2. Be able to operate hoist equipment under any conditions.
 3. Be able to pin point problems with field equipment and hoist unit.
 4. Have the ability to teach all you know about Casedhole Solutions, Inc. operations and their equipment to operators that work with you.
 5. Have the ability to coordinate your work and crew on location so as to get the maximum performance possible.

- **OPERATOR DUTIES**
 1. Be able to perform all rigging requirements with minimum supervision.
 2. Know how to use each scale on the fluke meter.

- Sedentary Work**
Lifting 10 pounds maximum and occasionally lifting and/or carrying such articles as docket, ledgers and small tools.
